COMMENCING at a found 4-1/2 inch by 4-1/2 inch concrete monument with a ¾" square iron rod inside for the Northwest corner of the called 160.310 acre tract mentioned above, the Southwest corner of a called 93.644 acre tract as described in a Deed of Trust to David R. Boruff (Doc #: 2020012442) and same being in the generally fenced and Southeast line of a called 13.438 acre tract as described in a Deed to Barry J Barnes, et ux (2019003728);

THENCE S 75°49′29″ E, 2,406.27 ft., along a portion of a fenced and Southwest line of said 93.644 acre Boruff tract, a portion of the generally fenced and Southwest line of a called 40.020 acre tract as conveyed to The Garza Family LP (2020073035) and a portion of the Northeast line of the called 160.310 acre tract mentioned above to a set 5/8 inch iron rod, 2.5 ft. THENCE S 75°49′29″ E, 147.49 ft., along a portion of a fenced and Northeast line of the called 160.310 acre tract mentioned above and a portion of the Southwest line of said 40.020 acre Garza tract to a set 5/8 inch iron rod, 2.5 ft.
